Quorum was established with 45 members in person and 16 via zoom.

## 2022 Annual Report of the Senior Pastor, Rev. Jennifer Gingras

A mentor once remarked to me that half of ordained ministry is just the work of showing up. As I enter my 16<sup>a</sup> year as a pastor at MCC, I can say with certainty that it's a little more complicated than that. Showing up also requires being attentive to another's needs, an ability to listen, to avoid giving advice (unless needed) and to ask the appropriate clarifying questions.

I've been thinking a lot at the turning of the year about the advantages and disadvantages when it comes to pastoral longevity. It was good that people knew me long enough to trust my recommendations about COVID protocol, especially as the pandemic shifted to an endemic. Did everyone agree with every decision I made? No. But they respected their connections with their faith community enough to do what church leadership and I deemed best. I'm not sure that respect would have been afforded me were it not for our long-term relationship. Other faith communities haven't weathered this storm as well as we have, and I hope that you will join me in praying for communities that struggle under the stress.

One obvious disadvantage to staying at a church too long is the potential for one's ministry to become stale. That's a main reason, churches who are able, give their clergy an extended period of sabbatical rest to do so, so that they might grow and learn. Thank you for supporting me through my third sabbatical. I appreciated all the catch-up conversations we've shared upon my return. I am indebted to my retired clergy colleague Rev. Peggy Allen for providing compassionate pastoral leadership in my absence, as well as our wonderful staff and lay leaders for all their help.

To keep things fresh, I offered a variety of adult education opportunities, by zoom and in person. Our Lenten series, Witness at the Cross (by Amy Jill Levine) was a popular series. Later in the spring, I focused on our church's history in preparation for traveling to places where our founders came from. I'm particularly grateful to church historian Gary Thompson for providing his wonderful book *Binding Covenant*, and also his energy in writing biographical sketches of the founders. In Advent, I offered a three-part series, Christmas on the Screen, with a small number of people on zoom and at Thursday morning Bible study. It may be that Advent is not a great time for an extra learning opportunity on zoom, or the topic just wasn't compelling enough for many people. On the positive side, Thursday morning participation was great!

I've come to learn that the longer I stay, the more potential there is to grieve the loss of people I care deeply about. The PF'ers I laughed (and cried) with on mission trips grow up, some may move away and start their young adult lives (as they should). Other folks relocate, and although many retain connection by watching the livestream on Sunday, I still miss seeing them regularly. Then there are the deaths. Just prior to Strawberry Festival, we hosted a memorial service for Jim and Gretchen Davison, members who were quite active at MCC when I first came, who had moved away in retirement. I also laid to rest the earthly remains of Lauren Rousseau, one of the teachers who was tragically killed ten years ago at Sandy Hook Elementary. At the end of the summer, our community lost two cherished active members; Sue Crea and Susan Walker. I was honored and humbled to be allowed the opportunity to comfort their families and celebrate their lives upon my return in October.

How fortunate we are to have so many new faces in worship and at programs this fall! I am working on connecting with all of them, but I also encourage you to get to know them and invite them to partake in all the activities we provide. We must all do our part to make everyone feel welcome and included. The constitutional review group, led by Moderator Arlene Redmond, have been diligently working on a constitutional update so that newcomers (and even those who have been around a while) will find our procedures more understandable in the future. I believe their work will be received well by the church and will help our newer folk integrate quickly with all the wonderful mission and ministry we have to offer.

I'd like you to know about the different opportunities I've taken to serve the town of Monroe this year. You may not know that I am on the Juvenile Justice Review Board, a small group that meets at the Police station to help minors who have had minor infractions make necessary restitutions and hopefully change the trajectory of their lives for the better. In the spring, I held a Vigil for Peace in Ukraine, inviting townspeople to come and reflect. In June, as the pastor of the only Open & Affirming church in town, I was asked to give the invocation at the raising of the pride flag at town hall. In October, I was asked to do the invocation for the Think Pink Vigil at town hall. It was especially meaningful to me, as I had recently learned of a dear friend diagnosed with breast cancer.

In the wider church world, I served a third year on our conference's Unified Fitness Review Board, which adjudicates the standing of clergy that are accused of boundary violations. I also served a deeply powerful week at Silver Lake Conference Center as Camp Chaplain – a role I had never done before. I sat on an advisory panel of pastors of churches that had gone through the ONA process for one of our neighboring churches. And, as one way of staying fresh with my advocacy work on achieving a just peace in the middle east, I participate in a monthly Palestine/Israel Solidarity Circle with UCC Clergy from around the country. We all need ways to increase our vision of what can be, in the midst of all that is.

The great Maya Angelou once said "*If you must look back, do so forgivingly. If you must look forward, do so prayerfully. However, the wisest thing you can do is be present in the present… gratefully.*" In 2023, this will be my highest dream and goal – to continue to be present in the present, gratefully.

#### Historian's Annual Report 2022

This was a year of multiple and significant anniversaries for the congregation. On April 10<sup>th</sup>, following worship, we celebrated Pastor Jenn's fifteenth year with us as a settled pastor; the first five as Assoc. Pastor, the past ten years as Sr. Pastor. June 7<sup>th</sup> marked the 100<sup>th</sup> anniversary of the incorporation of MCC, thus dissolving the Ecclesiastical Society. In June we celebrated the 50<sup>th</sup> anniversary of the modern day Strawberry Festival and the 150<sup>th</sup> of the very first one. Interviews and historical presentation displayed in the Meeting House on that weekend were featured in the *Monroe Sun*, the local "on-line" newspaper. We acknowledged the 175 year anniversary of the last worship service in the old Meeting House, June 13<sup>th</sup>, and, the 175 year anniversary, on June 22/23<sup>rd</sup>, of the first worship services in the current Meeting House. We celebrated the 175<sup>th</sup> anniversary of its dedication on Dec. 15<sup>th</sup>. And October 22<sup>nd</sup> was the 150 year anniversary of the deed for the Centre Green conveyed to MCC and St. Peter's.

A large number of documents were gratefully received for archiving from several member of the congregation.

Computerization of membership records from 1810 to 1936 was completed, along with baptisms, marriages, death records. The file will be added to as more records are found.

In light of the 175<sup>th</sup> anniversary of our Meeting House, pictures that have been filed over the years will be taken out mothballs and added to the gallery display that has been started in the rear entrance of the Meeting House.

### **Board of Deacons Annual Report 2022**

The Board of Deacons works with the Senior Pastor to assist with the worship service and as appropriate, to assist with the pastoral cares of the church community. Worship service assistance is provided through our welcoming of all individuals to worship and the role of the Deacon of the Day every Sunday in providing an opening prayer and read the scripture limiting the number of people coming to the podium. Communion returned to the traditional trays and plates with the exception of continued use of the plastic cups. Deacons also participate in special services such as Confirmation dinner and service, new member meeting, memorial services, Ash Wednesday, Maundy Thursday and Christmas Eve. They also take a month to host coffee hour.

Highlights for this year:

- We celebrated Pastor Jenn's 10 year anniversary as Senior Pastor in April.
- Spit guard was taken down in April and mask wearing became optional in October.
- Music Committee meetings were held frequently and as needed to ensure a rich musical experience for our members.
  - Chancel choir returned but will continue to remain masked.

- Pastor Jenn went on sabbatical from July-Sept. During that time Rev. Peggy Allen filled in while Vaughan Askue and Sheldon Smith covered for her on a couple of Sundays when she was not available.
- A scripture reading schedule was created with volunteers towards the end of the year.
- Flowers will be picked up by the Deacon of the Day from Big Y.
- Our Advent Study is Christmas on the Screen: Reviewing the Evolution of American Spirituality.

## **Board of Christian Education Report 2022**

## **Outreach Board Annual Report 2022**

**St. Georges Supper:** In 2022, the Outreach Board sponsored six suppers for homeless people in Bridgeport. Because COVID rules still apply, these consisted of "bag lunches" consisting of sandwiches (ham and cheese or turkey and cheese), an apple, a bottle of water, condiments and a snack consisting of chips or an energy bar. Hopefully we can resume providing full hot meals some time in 2023.

**Ukraine:** On March 20, MCC held a service of concern over the Russian invasion of Ukraine. A total of \$1,750.75 was donation to Ukrainian relief efforts. The flowers used during the service were given to Christine Wittenauer who has relatives in Ukraine.

**Wine tasting:** Still concerned about COVID, the wine tasting happened on the Pierce Lawn on October 1. Many thanks to Roy Nealon for being the MC and wine expert. \$600.00 was provided to the Center for

Family Justice for the Empower House; a safe residence for people who are forced from their homes by domestic violence.

**Spaghetti and Bingo night:** On Saturday, November 19, Outreach and the Fellowship boards teamed up to provide a spaghetti dinner and bingo night. The meal was excellent with meatballs, salad and both gluten and gluten-free pasta. Pastor Jenn served as our caller and there were all sorts of prizes and a silent auction. Over 100 people attended and about \$1,744.88 was collected. After expenses, \$1,375 was provided to Project Warmth; serving people in Monroe who are having trouble heating their homes in the winter. Many thanks to Leanne McEvoy for taking the lead on this and all the others who dove in to provide resources and help. So many people had so much fun that we might have created a recurring annual event.

**Crop Walk:** Julie McClenathan again led crop walk team MCC which accounted for \$3,404 in contributions.

Tag Sale: The board decided that the tag sale should resume in spring 2023.

In November, being one of this region's most generous churches to the Covenant to Care program, MCC was asked to start a new partnership with Covenant to Care and CAFAF (Connecticut Alliance of Foster & Adoptive Families). We started off with a bang, donating a record breaking 27 food baskets to families facing difficult times this Thanksgiving. With our new partnership came a new program for giving children Christmas gifts. We donated unwrapped gifts, which were picked up by Samantha Heltke, our CAFAF Advocacy and Support Services Reginal Liaison, and brought to her office were several social workers could "shop" for the perfect gifts for the children on their client list. The gifts were then given to the foster or adoptive parents, along with packages of donated wrapping paper, bows, and candy canes, so the parents could join in the joy of giving by wrapping their child's gift. MCC members supplied 65 unwrapped Christmas presents to the program!

## **Trustees Annual Report 2022**

The Trustees are responsible for maintaining the MCC campus and managing the finances of the church. MCC is truly a community of caring individuals who support the church with their time, talents and gifts. Thank you to all members and friends of the church.

During 2022, the Board replaced sheet rock in the two upstairs rooms and painted the interior of the parsonage. We installed Phase One of the electronic keypad entry for the front door of Rexford House. The push bars on the front and rear doors of Rexford House and on the side door of the Meeting House were also replaced. Since these capital improvements were not budgeted for 2022, we funded these projects through a \$6000 withdrawal from the Wilton investment fund. Thank you to John O'Rourke for his continuous attention to the MCC investment accounts.

In December, three required fire alarm pulls were installed in the Meeting House. Many thanks to Dave Allen for overseeing the projects and for his 19+ years as Property Manager of MCC.

In March of 2022, we welcomed a new family as tenants of the parsonage, which is now generating \$2200 per month in rental income. Things seem to be getting back to normal as organizations and others inquire about rental space in Rexford House. This includes the Monroe Summer Day Camp, the Lenihan School of Irish Dance, Boy Scouts, Girls Scouts and others. It's wonderful to see our campus being used by various groups. A special thank you to our office administrator, Diane Prall, who coordinates the rentals with the Board and diligently keeps records of all transactions.

We continue to video stream our worship services in order to reach those who are not able to attend church in person. We give thanks to Scott Young for his consistent monitoring of our remote services and meeting our technical needs.

MCC received a PPP loan in 2021 in the amount of \$42,700. In May of 2022, MCC completed the application to Newtown Savings Bank for the forgiveness of this loan. Thank you to Frank Wittenauer and Bill Stadler for their diligence in this matter.

This fall, we learned from the IRS that seven years ago, there were clerical errors in filing three quarterly required employer- tax forms. The Board voted to pay the outstanding payroll taxes due in three increments of \$4600 each in November and December of 2022 and January of 2023. The IRS agent assisted Bill Stadler in applying for forgiveness of the interest and penalties that will be assessed. Since this expenditure was not budgeted for 2022, we are funding these payments from the interest on our investment accounts.

The Trustees coordinated work days in the spring and fall of this past year. We are overwhelmed by the number of volunteers who trimmed bushes, carted away the debris, cleaned gutters, changed light bulbs, organized closets in Dineson parlor, cleaned the pews and floor, and painted the feet of the pews in the Meeting House. The Board thanks everyone who helped spruce up our buildings and grounds.

The Trustees thank all who have pledged to this year's stewardship campaign. The majority of our revenue comes from pledges which support our church's ministry. MCC has responded to the various challenges of the past two years with consideration and care for each other. Under God's direction and with your support, MCC will continue to welcome everyone, wherever they are on their faith journey.

\*Helen G. Sherman Trust – this was initially established in 1995, in the amount of \$154,798 and was restricted as follows: principal is restricted, but income may be used consistent with MCC's tax-exempt purposes as governing body shall designate. In 2002, 500 units of the Helen G. Sherman trust were sold and \$31,475.77 was distributed to the church.

\*\*Clara Johnson Trust – this was initially established in 1998, in the amount of \$67,621.40 and was restricted as follows: principal is restricted, but income used for care, maintenance and upkeep of church building and pastor's salary.

\*\*\*Wilton Estate Fund – this was received in March of 2014 in the amount of \$403,000. There are no restrictions or specified use attached to these funds. \$200,000 of this fund was added to the investment account in June of 2014, with the remainder going into MCC's Money Market account, with the expectation that some of these funds would be used to support the renovation of Rexford House, as well as replacement of the organ in the Meeting House.

General Investment Fund – represents income accrued from the other investment funds and is what we pull from to fund MCC operations each year.

# MONROE CONGREGATIONAL CHURCH UNITED CHURCH OF CHRIST PROPOSED 2023 BUDGET

The Proposed 2023 Operating Budget as recommended by the Board of Trustees is presented on the reverse side. MCC is projected to conclude 2022 with a modest operating surplus. While this looks like positive news, it should be noted that this was made possible by withdrawing extra funds from our investment account to support some unexpected costs and shortfalls on income.

Below is a summary of the significant changes and key assumptions underlying the Proposed 2023 Budget to be presented at Annual Meeting.

## **Revenues:**

- Pledge income is projected at \$200K, which includes prior year collections, which is the same as the previous year.
- Rental income is projected at \$58,500, which includes income from renting the parsonage at \$2200/month, net of property taxes of \$7000. It also includes rental income from Gingerbread, Rexford House and continuation of hosting the Monroe Summer Day Camp on campus during the summer months at an increased rate.
- Income from investments is projected at \$25K which is the recommended withdrawal amount to maintain the inflation-adjusted principal in our investment accounts.
- Strawberry Festival net income is budgeted @ \$30K which is based on our ability to conduct a "normal" festival event this year.
- The Mustard Seed contribution is \$5K, which was confirmed by the Mustard Seed Board. Again, this number is based on a return to more normal operations and volunteer support.

#### Expenses:

- Compensation & Benefits is expected to rise to \$230K, which includes a modest (2%) cost-ofliving adjustment for staff the pastor's housing allowance of \$1650/month for 12 months.
- Facility costs are budgeted at \$80K, which reflects expected increases in electricity, oil and other costs to run our facilities.
- Program costs are budgeted at \$15K, and office expenses are budgeted at \$4500, reflecting significant savings over prior years on postage, printing and other costs.
